Their appointments are subject to the following terms and conditions:-

Terms & Conditions

1. Your appointment will be purely on Project basis as Data Entry Operator with fixed pay package of Rs.35,000/- (will not increase) and no other allowances will be admissible.
2. Your appointment period will start from 15th May, 2024 to 30th June, 2024 which is not extendable in any condition. You can join service from 13.05.2024 however, job and duties will be started from 15th May, 2024.
3. Your onsite / Jail online training will start from 20th May, 2024 to 24th May, 2024. You Payroll will start subject to successful completion of training.
4. Your services are liable to be terminated on account of poor performance / unsatisfactory conduct or un-authorized / willful absence from duty.
5. You are bound to observe prison service discipline in the light of PPR, 1978.
6. You will be governed by the Leave Rules 1981 or Revised Leave Rules issued from time to time. However, provisions contained in rules, 6, 8, 10, 11, 13, 33, 34, 35 & 38 shall not apply. However, all leave at your credit shall lapse on the date of final expiry or termination of the project.
7. Medical facilities will not be admissible under the relevant rules and regulations.
8. You will be bound to follow all rules enforced by the Government of the Punjab.
9. Your services rendered under the present project shall not qualify for pension or gratuity.
10. You are not entitled to apply through proper channel for another post under the Federal or Provincial Government or its subordinate offices / organizations / institutions, till the completion of the said Project.

11. You must submit an affidavit to the concerned Superintendent Jail (place of posting) that you will not leave the service before completion of project and you have no right to apply for NOC for employment in other Department during project period.
12. In case of resignation from service, you will be bound to give one month's notice to the Appointing Authority and deposit an amount equivalent to one month salary.
13. You will be required to submit Medical Fitness Certificate for first entry into Government Service issued from Medical Superintendent DHQ Hospital concerned. No TA / DA is admissible for initially joining the place of posting.
14. Your appointment will be proceeded subject to the verification and clearance of antecedents by the Police / Special Branch.
15. If degree / certificates of academic qualifications are found bogus / forged subsequently etc. at any stage, Appointing Authority shall have legal right to cancel your appointment besides initiation of criminal proceedings.
16. Your appointment will be proceeded subject to the verification that you have not married with foreign national.
17. You are liable to be posted anywhere in the Punjab, in future.
18. You are liable to provide copies of all credentials i.e., educational certificates, domicile and passport size photographs (04) to the concerned Superintendent Jail at the time of joining.
