- ii. Officers/Officials who have been made OSDs or who have been directed to report to the Prisons Department/Home Department/S&GAD on the charges of inefficiency/misconduct or indiscipline.
- iii. When Officer/Official is on leave beyond 90 days, extra ordinary leave, study leave or training abroad.
- iv. Those who are not working in Prison Department.
- v. The referred allowance will not be counted towards pension and commutation/gratuity.
