**NOTIFICATION**

No. SO (Prs) 18-24/2009. Sanction is hereby accorded for the following with effect from 26.09.2009.

- i. Up-gradation of post of Assistant Superintendent Jail from BS-14 to BS-16, Deputy Superintendent Jail BS-16 to BS-17, Superintendent District Jails BS-17 to BS-18, Superintendent Central Jails/AIGs from BS-18 to BS-19, Deputy Inspector General of Prisons from BS-19 to BS-20 and Inspector General of Prisons from BS-20 to BS-21, alongwith regular incumbents subject to the condition that the incumbents hold the post substantially prior to up-gradation.
- ii. Creation of 598 posts of Sanitary Workers (BS-1), 1510 posts of Warder (Male/Female) (BS-05), 151 posts of Head Warder (BS-07), 21 posts of Chief Warder (BS-09), 04 posts of Assistant Director (BS-17).
- iii. Creation of an independent Medical cadre. Splashing of posts will be calculated in due course.
- iv. Sanction of Prisons Allowance @ one month pay equal to Initial of the relevant pay scales to the officers/officials of Prisons Department. With the introduction of the subject allowance no one is entitled to any other allowance/Special Pay as the case may be.
- v. Sanction of Dress/Uniform allowance of Rs.250/- for Assistant Superintendent Jail/Deputy Superintendent Jail, Rs.500/- for Superintendent Jail, Rs.1000/- for DIGs Prisons and IG Prisons.
- vi. Sanction of Washing Allowance @ Rs.100/- p.m.
- vii. Sanction of Ration Allowance @ Rs.1000/- p.m.

2. The allowance mentioned at (para-iv) above is not admissible to the following officers/officials:-

- a) Officers/Officials under suspension.
- b) Officers/Officials who have been made OSDs or who have been directed to report to the Prisons Department/Home Department /S&C/D on the charges of inefficiency/misconduct or indiscipline.
- c) When officer/official is on leave beyond four months, extraordinary leave, study leave or training abroad.
- d) Those who are not working in the Prisons Department.


